Its power is limited by the other two branches of government. The President nominates justices to the court. The Senate must vote its approval of the nominations.

As the final arbiter of the law, the Court is charged with ensuring the American people the promise of equal justice under law and, thereby, also functions as guardian and interpreter of the Constitution. The Supreme Court consists of the Chief Justice of the United States and such number of Associate Justices as may be fixed by Congress.

Congress first exercised this power in the Judiciary Act of 1789. This Act created a Supreme Court with six justices. It also established the lower federal court system. The Justices Over the years, various Acts of Congress have altered the number of seats on the Supreme Court, from a low of five to a high of 10.

“The judicial Power of the United States, shall be vested in one supreme Court, and in such inferior Courts as the Congress may from time to time ordain and establish,” it reads. The Judiciary Act of 1789 established the first Supreme Court, with six Justices.

The U.S. Supreme Court. The Judiciary Act of 1789 set the size of the court at six; one Chief Justice and five Associate Justices. Over time, the court grew to as large as ten Justices. With the Judiciary Act of 1869, Congress decreased the number to nine, a number which has remained constant to this day.

A second less common way in which cases reach the U.S. Supreme Court is through an appeal to a decision by one of the state supreme courts. Each of the 50 states has its own supreme court that acts as the authority on cases involving state laws. Not all states call their highest court the “Supreme Court.”
